Match Information: The EDC is an annual WSRPA championship match that includes the extracted WSRPA distinguished "leg" match. Course of fire for the championship is an RMC80 from which an NMC is extracted for the leg match. The NMC consists of the first ten shots each standing, RS, RP plus all 20 SP. WSRPA or the shooter's home state association membership is required for the Championship. For the "leg" match, WSRPA membership is required for all shooters. Membership is normally verified at registration.

Directions: From the intersection of Division Street (US 395) and Francis Avenue (SR 291) Head West on W Francis Ave 3.0 Miles toward N Assembly Street; Continue West onto W Nine Mile Road 0.7 Miles; Turn Left onto W Rifle Club Road 0.4 Miles to 6411 N Aubrey L White Parkway; Go thru the gate on the west side of Aubrey L. White Parkway and proceed downhill, at 10 MPH, to the clubhouse.

Rules: The Current NRA High Power Rifle Rules will apply. Empty chamber indicators (Rule 3.21) will be available at the range and **MUST** be used by all competitors. CMP Rules prevail on Sunday

Competition is open to: Open to all NRA members and prospective members. Each junior competitor must be accompanied by a responsible adult who may act as a coach during firing.

Entries Close/Post Entries: Entries will close at 5:00PM on the Friday before the Match. Post entries will be accepted the day of the match only to fill vacancies on squads up to the range capacity. Please pay on match day. Cash preferred.

Entry Fee: \$35.00 Match Entry Fee Saturday (Includes matches 1 thru 5) per individual adult. Junior members of the Spokane Rifle Club will shoot for \$20.00. \$20 Sunday for all. Please pay on match day. Cash preferred.

Entry Limit: Entries will be accepted to the capacity of the range (30).

Firing Starts: Firing will commence promptly at 1:00pm Sat and 8:30am on Sunday

Match Schedule Saturday WSRPA E. Dist. Leg

- Match 1: Target: SR 200 yards, 20 shots, (plus 2 sighting shots, 2 minutes) slow fire, standing, 20 minutes.
- Match 2: Target: SR 200 yards, 2 strings of 10 shots, (after 2 sighting shots, 2 minutes for each string) rapid fire, sitting/kneeling, 60 seconds per string.
- Match 3: Target: SR-3 300 yards, 2 strings of 10 shots, (after 2 sighting shots, 2 minutes per string) rapid fire, prone, 70 seconds per string.
- Match 4: Target: MR-1 600 yards, 20 shots, (plus 2 sighting) slow fire, prone, 22 minutes.
- Match 5: The Aggregate of scores fired in Matches 1 thru 4

Match Schedule Sunday CMP EIC Leg Match

Match begins at 600 yards and finishes at 200.

Awards: Prizes will be awarded to top finishers for each classification of competitors having 5 or more competitors. When there are insufficient entries in any class to warrant an award in that class, the individual or team involved may be moved by the Match Director to a higher class.

General Information:

Squadding: All matches will be squadded. Competitors are required to pull targets or provide someone to do so.

Competitors must report to the Stat Office before firing. NRA classification card must be shown before squadding is issued. A competitor who fails to present himself/herself at the proper firing point when his/her relay is called may lose his/her right to compete in that event.

Classification of Competitors:

19.1 Classified Competitors - Classified competitors are all individuals who are officially classified by the NRA for High Power Rifle competition, or who have a record of scores fired over courses of fire used for classification (See Rule 19.4) which have been recorded in a Score Record Book.

19.2 Unclassified Competitor - An unclassified competitor is a competitor who does not have a current NRA High Power Rifle classification, either regular or temporary by Score Record Book (Rule 19.14), nor an "Assigned Classification" (Rule 19.6). Such competitor shall compete in the Master Class.
